

Items Encouraged in Residence Hall Rooms:

- Bed Linens- sheets, blanket, mattress protector, pillow, etc. (twin, extra-long)
- Shower Supplies- Towels, Shower Shoes, Caddy/Bucket
- Laundry Supplies- Basket/Bag, Detergent (liquid high efficiency type for our front-load washers)
- Hangers
- Adhesive strips that are non-harmful to surfaces after removal (Command Removable Adhesive strips, for example)
- Toiletries
- Scissors & Sewing Kit
- Alarm Clock
- Desk Lamp
- Pens, Paper
- Adjustable Window Screen (windows range from 38.15"-41.5" wide)
- Fan
- Expandable Curtain Rod (to hang a curtain over the window or hang curtain as a closet door)
- Area Rug
- First Aid Kit
- Storage Bins (max height of 14" if intended to fit beneath most of our beds)
- Multi-Plug Power Strip with Surge Protector (extension cords without a surge protector are not allowed)
- Iron (with automatic shut off)
- Cell Phone
- PC or Laptop
- iPod/MP3 Player
- Bike with a Secure Lock (cable locks are not recommended)
- Television – Note that to be compatible with our cable services, all sets must be digital with a QAM tuner installed and students must provide their own coaxial cable. Most name brand digital flat screens have a QAM tuner but students are advised to verify this with the manufacturer before making a purchase.
- Ethernet cable - If you prefer to directly connect to our data services rather than rely on Wi-Fi (which is provided with no equipment needed.)
- Microwave & Refrigerator - 1 refrigerator (up to 1.5 amp, 4.0cu.ft.) and 1 microwave (up to 700 watts) allowed per room so roommates should coordinate on this. Roommate information is mailed out in mid-July.

Items Not Allowed in Residence Hall Rooms:

- Any item with an exposed heating element. This includes toaster ovens, deep fat fryers, hot plates, grills, traditional coffee pots, etc. (Keurig and similar styled pots without an exposed heating element are allowed.)
- Halogen lamps, candles, incense and any item with an open flame, wick or calls for burning.
- Any appliance over 1,800 watts.
- Extension cords.
- Space heaters.
- Computer routers.
- Hoverboards or similar devices.
- Adhesives/tapes or hardware that will harm surfaces after removal (double sided tape, duct tape, screws, etc.) if used to attach items to NCWC owned surfaces (i.e., walls, doors, furniture, etc.). Students will be charged for damages caused by use of these materials.
- Weapons of any type. This includes, but is not limited to firearms, knives, martial arts equipment, bows and arrows, spears, etc. This applies to all members of the campus community, including those holding a concealed-carry permit.
- Substances banned by the campus-wide alcohol, tobacco and drug policies as well as any related paraphernalia (including alcohol container collections; smoke, smokeless and e-vapor tobacco products, etc.). Wesleyan is a tobacco and alcohol-free campus.
