



**2022-2023 Unusual Enrollment History Review Form**

Your 2022-2023 Free Application for Federal Student Aid (FAFSA) has been flagged for “Unusual Enrollment History Review” by the U. S. 2. Provide your own written statement describing the reasons and the extenuating circumstances if you failed to earn any academic credit at any attended college. Be specific and concise in your explanation. Incomplete information may cause a delay in the review of your form or denial of your request.
3. Attach any additional documentation (i.e., medical bills, hospitalization records, accident reports, etc.) that supports your particular situation. ***A complete medical history is not necessary.***
