



2022-2023 Custom Verification (V4) – Identity and Statement of Educational Purpose

Your 2022-2023 Free Application for Federal Student Aid (FAFSA) has been selected for review in a process called "Verification". Regulations require that before awarding Federal Student Aid, if selected for Verification, we must ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information, the Office of Financial Aid at North Carolina Wesleyan University will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, the Office of Financial Aid will submit the corrected information to the US Department of Education.

The financial aid office cannot process your financial aid award until verification has been completed, so it is imperative that you provide the required documents as soon as possible.
